Hi,

At a recent MMCCC meeting, a concern was raised about intersection signage from a concerned landowner - Mr Jamie Evans (email attached).

Murray Zircon Mining is writing to express our strong support for the community action request submitted by Mr Jamie Evans regarding the replacement of the current give way signs with the installation of stop signs at the intersection of East Murray Area School Rd, Evans Rd, and Walkers Flat Rd.

As a local business, we are deeply invested in the safety and well-being of our community. The concerns raised in the request are both valid and urgent.

Our employees and landowners frequently travel through this intersection, and we have been informed via a meeting of the Murray Mallee Community Consultative Committee that there have been numerous instances where vehicles fail to yield appropriately, posing a significant risk to all road users, especially those unfamiliar with the area.

Replacing the 'Give Way' signs with stop signs and implementing speed reduction measures would greatly enhance the safety of this intersection. It would ensure that all vehicles come to a complete stop, allowing drivers to navigate the intersection more safely and reducing the likelihood of collisions.

We strongly urge the council to consider these changes. The safety of our community members and road users is a top priority for us.
